ASSUMPTION OF RISK AND WAIVER OF LIABILITY AGREEMENT FOR COMMUNICABLE DISEASES INCLUDING COVID-19
TO BE SUBMITTED FOR ENTRY INTO THE FACILITY

In consideration of being allowed to participate in the 2022 Feis Na Cara I acknowledge and agrees that:

1. My participation and the participation of my dancer includes possible exposure to an illness from infectious diseases, including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness, injury, and death does exist despite precautions that are taken. A preexisting health condition, exposure to COVID-19 or any other infectious disease may be more likely to cause serious illness, injury, or death.
2. As a condition of my and my dancer's participation in Feis Na Cara, I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others and assume full responsibility for my participation.
3. I willingly agree to comply with the stated and customary terms and conditions for participation as regards protection against infectious diseases – WHICH INCLUDES WEARING A MASK. I also acknowledge that refusal to comply with the stated terms and condition may result in immediate removal from the Feis for both myself and my dancer with NO REFUND of fees.
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, SHALL RELEASE AND HOLD HARMLESS The McDade-Cara School of Irish Dance, Cardinal O'Hara High School, Archdiocese of Philadelphia, and their sponsors, officers, officials, agents, volunteers and/or employees, other participants, sponsoring organizations, individual sponsors, advertisers, and if applicable, owners and lesser of the premises ("RELEASEES"), used to conduct Feis Na Cara or any events incidental to this activity, WITH RESPECT TO ANY AND ALL ILLNESS, DISABILITY, DEATH, or loss or damage to person or property WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.
5. This agreement shall be governed by the laws of the State of Pennsylvania and any dispute involving this Agreement shall be brought in Delaware County, PA.
6. I consent to a temperature check for both myself and my dancer. If the temperature reading is above 100.4 entrance to the Feis will be denied with no refund of fees.
7. For those attending the event who reside outside the state of Pennsylvania, I have read all requirements for travel into the State of Pennsylvania as outlined on the Pennsylvania state website at <https://www.health.pa.gov/topics/disease/coronavirus/Pages/Travelers.aspx> and state that I am following all of these requirements for travel as outlined and instructed.
8. I HAVE READ THIS ASSUMPTION OF RISK AND WAIVER OF LIABILITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
