

COVID 19 PRECAUTIONS

All attendees must wear a mask at all times. Even though the feis is outdoors, masks are still required. They must be worn correctly over the nose and mouth. Please no gator style, face shield, scarves or bandanas or masks with vents. If you arrive without a proper mask, one will be provided to you. If you have a medical condition that precludes you from wearing a face mask, we respectfully ask that you don't attend the feis this year. All attendees must maintain a 6 foot distance when possible, including camping areas. The feis committee will implement and enforce strict Covid-19 policies in accordance with local, state, and federal guidance. All attendees must adhere to the rules and policies. Masks will be worn by dancers at all times except when a dancer is competing on stage.

DANCING

All dancing will take place outdoors over 6 stages. Again ALL ATTENDEES MUST WEAR A MASK AT ALL TIMES except when a dancer is competing on the stage. Dancers must bring a small paper bag in which to place their mask, with their name clearly marked on it to leave side stage while dancing. Dancers may choose to dance in a mask without penalty. No masks should have identifying markings on them. All dancing will be done 2 at a time on a separated stage. There will be a break after each competition to allow dancers to leave the area and disinfecting to be done. The feis committee reserves the right to combine any competition. There will be no day of competition entries or changes accepted. There will be NO camping allowed in or around any of the stages, but camping is ALLOWED in the open fields of the venue. Tents and chairs are allowed in those open fields. All dancers must arrive on time and as ready to go as possible: ie, with hair, makeup, tanning already done. There will be no hair, tanning or makeup application allowed in any of the public restrooms or common spaces.

SPECTATORS

Only 1 support person per dancer will be allowed entry to the feis, no exceptions. There are no spectators allowed to sit under the big tent. Viewing areas will be clearly marked and spectators will need to remain socially distant.

ENTRE FEES

Before registering, please check your local school, work, and travel advisory rules. There will be absolutely NO REFUNDS even if you are not allowed to attend the feis. The feis committee has to pre-pay for much of the feis weeks before the feis and the funds will not be available for any refunds even for reasons due to the pandemic including illness, changes in quarantine requirements or weather. If the feis is cancelled for any reason, refunds will be issued to all competitors minus the gate fee and feis web fee will be refunded. We will not respond to any requests for refunds.

Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be extremely contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and/or by contact with contaminated surfaces and objects, and even possibly in the air. People reportedly can be infected and show no symptoms and therefore spread the disease unknowingly. The exact methods of spread and contraction are unknown, and there is no known cure for COVID-19. Evidence has shown that COVID-19 can cause serious and potentially life threatening illness and even death.

The Greater Boston Irish Dance Teachers, LLC and Irish Cultural Center cannot prevent you or your child(ren) from becoming exposed to, contracting, or spreading COVID-19 while attending the Greater Boston Irish Dance Teachers Feis.
